# **Apple Creek Golf Course**

## **General Terms and Conditions of Membership**

Members of Apple Creek Golf Course ("Apple Creek") agree to abide by the terms and conditions set out below.

### ***General:***

- An annual membership is effective from Opening Day (Determined by Apple Creek) to the Closing Day (Determined by Apple Creek)
- Membership is valid during public golf and league designated play (for those memberships that include league play). Members agree that Apple Creek reserves the right to close the course for private tournament rental or other use at its discretion.
- Membership is non-assignable and non-transferrable. Only the person named in the membership application may play under the membership.
- Membership is for course playing privileges only and does not include any equipment rental or other services.
- All memberships are non-refundable.
- Members shall comply with all Apple Creek rules and regulations.
- Members are required to keep current contact information on file with Apple Creek at all times, including their postal address, email address, and at least one phone number.

### ***Liability:***

- In case of personal injury or damage to personal property, the Member agrees that the use of Apple Creek or its associated facilities are done at the member's own risk.
- In no event, shall Apple Creek be liable to the Member for damages of any kind whatsoever in an amount in excess of \$500.
- Apple Creek shall not be responsible for lost, stolen or damaged property.

### ***Etiquette:***

- Consideration and courtesy of fellow members, guests and employees of Apple Creek is expected at all times. Members agree to follow all on-course instructions given by course marshals.
- Proper attire is required. Members will abide by the dress code that may be in effect for both the golf course and the clubhouse.
- Foul language and abusive behaviour will not be tolerated. Your membership may be terminated, without refund, for use of foul language or abusive behavior.
- All members shall check in at the pro shop before teeing off.
- All members and guests will obey the laws of Alberta, including applicable liquor laws, while at Apple Creek.

***Charging Privileges:***

- A member may elect to provide Apple Creek with a credit card in order to allow the Member to charge for food, beverages, merchandise, and services, together with any applicable taxes or similar charges.
- Apple Creek will apply all charges to the Member's account to the Member's credit card on file at the end of the day in which the charges are incurred or as soon as practicable thereafter.
- Members that elect to have charging privileges at Apple Creek are required to keep current credit card information on file with Apple Creek at all times for payment of their account and authorize Apple Creek to use this information to settle all charges in full.

***Termination of Membership:***

- Apple Creek reserves the right to terminate any membership, without a refund, in the event: (i) the Member breaches any of Apple Creek's rules or regulations, which determination shall be made solely by management of Apple Creek; or (ii) the Member fails to pay Apple Creek any amount due for membership dues or charging privileges.
