



Apple Creek Ladies League A.C.L.L.

- 2017 annual non-refundable registration fee: \$110.00 payable upon registration. ONLY Payment will secure membership – see registration form.
- Ladies wishing to play during the regular Ladies League times must pay the registration fee regardless of participation in the year-end tournament.
- \$10.00 of this fee goes towards AGA registration.
- Remainder of the funds will be held in the ACLL account to be used towards the year-end tournament, banquet or other events organized by the Ladies League.
- Our year-end tournament will be held on Saturday September 23, 2017 (to be confirmed in late August 2017) with a shotgun start, 18 holes and a banquet to follow.
- **Only** members who have paid the registration fee will be eligible to participate in the year-end tournament and banquet.
- If we find that the registration funds will not cover the total cost of the wind up tournament a nominal fee will be posted before August 15, 2017.
- Tentative start date for Ladies League is scheduled for Tuesday May 02, 2017
- Last regular Ladies League Day will be Tuesday, September 19, 2017
- 9 holes every Tuesday evening, tee-times set aside from 1:00pm – 6:30pm. (Depending on daylight)
- New tee-time sign up sheets will be posted in the pro-shop every Tuesday for the following Tuesday.
- Ladies are welcome to book tee times in person each Tuesday on sign-up sheets located in the Pro Shop. If members are unavailable Tuesday to book a tee time for the following week, Wednesday will be open for telephone reservations through the Pro Shop. The Pro Shop will not be booking tee times for the Ladies League on Tuesday for the subsequent week; they will only accept telephone reservations for the current Tuesday of play. **403-912-2191**
- If you cannot make your tee-time, please call **403-912-2191** to cancel.
- Each week we will have a different “game” and allocate prizes accordingly. Prize pool will be \$3.00 per week. Games will be skill and luck based.
- Gift Cards will be awarded weekly for the winners of the games. The dollar amounts are based on number of participants that week. Every effort will be made to ensure that the value exceeds \$20.00* (see weather issue) per gift card, per week.
- Gift Cards can be redeemed in the Pro Shop; merchandise or green fees (not weekly prize fee), or in the restaurant.
- If there be a weather issue the following will apply
- If there are golfers on the course there will be winner’s chosen – no carry overs will happen. This could result in lower dollar value *gift cards.
- If there are no golfers, then the game will be carried over.
- We ask that even when playing a fun game that you keep up pace of play.
- ACLL members must be 18 years of age and older

- Ladies evening 9 holes discounted rate: \$31.50 includes GST. This includes green fees and cart including the \$3.00 prize pot the total cost is \$34.50.
- We welcome you to invite friends and family to participate as guests on Ladies League Tuesdays. Guests will be required to pay the regular green fees of \$31.50 (9 holes).
- Guests are eligible to participate in ladies' night **twice** during the golf season. Upon a third game, they will be required to register in ACLL and pay the \$110.00 registration fee.
- Guests will not be able to participate in the weekly prizes; nor are they allowed to purchase 50/50 tickets.
